

Information Clause about Image Processing**

The Controller of your personal data is Lubelski Węgiel "BOGDANKA" Spółka Akcyjna with its registered office in Bogdanka, 21-013 Puchaczów (hereinafter: the **Controller**).

Personal data in the form of your image or an image of a child whose parent/legal guardian you are* (personal image data) shown on one or more photographs taken during meetings with children and youth during educational classes in Zone C of Lubelski Węgiel "Bogdanka" S.A. on [date] will be processed in order to record the event and to build a positive image of the Controller in public space and social media by uploading your image or an image of a child whose parent/legal guardian you are* on the Controller's Fanpage in social media or the company newsletter or a local newspaper (depending on the scope of consent given) and/or at the Controller's website – based on your consent pursuant to Article 6(1)(a) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (hereinafter: GDPR) and pursuant to Article 81(1) of the Act of 4 February 1994 on Copyright and Neighboring Rights (Journal of Laws of 2022, Item 2509, as amended). The personal data will not be transferred to a third country within the meaning of the GDPR. The personal data will be retained for a period necessary to achieve the objective defined above, after which the data will be retained for a period specified by the statute of limitations for claims and criminal acts or for a period required by law, e.g. taxation regulations. The Controller may store the personal data for a longer period than indicated above only if this results from the obligation imposed on the Controller by the provisions of the generally applicable law or if there is another basis for processing your data as specified in Article 6(1) of the GDPR.

Providing your personal data, i.e. giving consent to data processing, including image dissemination, is voluntary.

You have the right to request: access to the content of your data, data rectification, erasure, restriction of processing, data portability, objection to personal data processing. If data is processed based on your consent, you have the right to withdraw this consent at any time without affecting the lawfulness of the processing which was carried out on the basis of the consent before its withdrawal.

The rights referred to above may be exercised by indicating your requests and sending them to the Data Protection Officer at the e-mail address: iod@lw.com.pl. You have also the right to lodge a complaint with the President of the Office for Personal Data Protection, if you feel that the processing of the Personal Data breaches the provisions of the GDPR.

Consent to processing, including image dissemination

Having familiarized myself with the above information clause, pursuant to Article 6(1)(a) of the GDPR and pursuant to Article 81(1) of the Act on Copyright and Neighboring Rights of 4 February 1994, I hereby **declare that I give consent to the processing of personal image data** shown on **one or more photographs of a child whose parent / legal guardian I am**, taken during educational classes in Zone C of LW Bogdanka S.A. to be processed in order to record the event and to build a positive image of the Controller in public space and social media by making the image accessible [if consent is given, please mark the right boxes below]:

- on the Controller's Fanpage in social media,
- in the company newsletter/local newspaper,
- at the Controller's website

giving permission, free-of-charge, for dissemination of my image/an image of a child whose parent / legal guardian I am* as described above by the Controller. This permission for image dissemination does not pertain to situations where dissemination of an image does not require permission in accordance with applicable laws, in particular in cases defined in Article 81(2) of the Act on Copyright and Neighboring Rights of 4 February 1994.

**If the event of consent-based processing of personal data of persons below 13 years of age, consent should be collected from the child's parent or guardian. If the event of consent-based processing of personal data of persons over 13 and below 18 years of age (and in the case of information society services within the meaning of the GDPR – below 16 years of age), consent should be collected from both the child and the child's parent or guardian. The preceding sentence is applicable, *mutatis mutandis*, to collecting confirmation of fulfillment of the information obligation with regard to personal data processing from minor children and their parents or guardians.
